CANCELLATION POLICY

- Cancellation notice must either be made in writing and mailed to the address listed above OR by email to: creativeowlhideaway@gmail.com. Cancellation date will be considered the postmarked/received date of the cancellation notice. Upon cancellation, the rental period will then be made available to other renters.
- If the reservation is cancelled 61 days or more before the rental period, the entire deposit and any rental payments will be refunded in **FULL**.
- If the reservation is cancelled 31-60 days prior to rental period, the reservation will need to be rescheduled or transferred to another person or the Renter will forfeit **HALF** of the entire rental fee.
- If reservation is cancelled 30 days or less of the rental period, **ALL** rental fees will be forfeited. (Some exceptions may apply).
- The Owner reserves the right to cancel this agreement in the event of an emergency or other unforeseen event. In this case, the renter will be allowed to reschedule or all deposits/payments will be refunded in full.

The Group Coordinator listed above will be responsible in providing all parties of the group and guests with a complete copy of this rental agreement including the Policies/Information packet from website and agree to abide by all information pertained within.
